The purpose of these release notes is to provide a summary of system enhancements included in NMLS Release 2016.1.

20664	Surety Bonds Account Creation	Electronic Surety Bonds Phase I includes the ability for surety companies and surety bond producers to request accounts in NMLS and the ability to establish business associations between them. SRR will approve all account requests. The business association in NMLS between a surety company and a surety bond producer is an electronic representation of the paper power of attorney and authorizes the surety bond producer to issue bonds on behalf of the surety company.  Regulators will have the ability to view surety entities and their associations in Composite View.	State

The NMLS Resource Center contains a summary of comments submitted on the Mortgage Call Report (MCR), including approved changes. These changes necessitate a new MCR form version which will be available on April 1, 2016. The print filing functionality will be available January 25, 2016.	State

		<ul> <li>Users now have the ability to upload a CSV file for the following sections         <ul> <li>Section III – Loans Serviced by Others.</li> <li>Section III – Loans Serviced for Others.</li> <li>Section III – Loans Serviced under MSRs on the Expanded RMLA.</li> </ul> </li> <li>To facilitate the ability to upload CSV files for Section III, a Delete All button is added to the Section III – Loans Serviced by Others, Sections III – Loans Serviced for Others, and Section III – Loans Serviced under MSRs sections so that all fields can be cleared prior to uploading CSV files for those sections.</li> <li>The completeness checks on the Standard and Expanded RMLA for AC070 are updated to reflect that AC070 Loans Closed and Funded are equal to ACMLOTOT in Mortgage Loan Originator Data.</li> <li>Six additional fields are added to the Qualified and Non-Qualified Mortgage reporting on the Standard and Expanded RMLA. 31099	Allow federal regulator to upload/enter a regulatory action against an entity or individual in NMLS	This enhancement will create a new federal organization user type for the Consumer Financial Protection Bureau (CFPB) and will allow that user type to upload regulatory actions against entities or individuals in NMLS. The current State Regulatory Actions functionality will remain unchanged, but is being renamed "Regulatory Actions." Ultimately, other federal agencies may be brought on to NMLS as well in order to upload regulatory actions.	State and Federal

31403	Duplicate Sponsorship Removal Review Items created	Duplicate Sponsorship Removal Review Items are generated from the Manage Sponsorship page when the regulator clicks on the Update Sponsorship button, even if nothing has changed on the page. The system will be updated to only generate the review item when the sponsorship has actually changed.	State		
31950	MCR - User was able to create two MCR filings	Company Users are able to create two MCR filings for the same period by double clicking on the Create Standard MCR button. The issue will be fixed by disallowing double clicking on this button.	State		
33058	SRR Invoice: Write off username is not being populated when an existing SRR invoice is flagged as write off	When an existing invoice is changed to write off, the write off username is not being populated. The system will be updated to populate the username when an invoice is changed to write off.	State		
33112	Consumer Access: Federal Registered MLOs count	The Registered MLOs Count displayed in Consumer Access includes all individuals with any registration status who have confirmed employments with the Institution. The count will be updated to show the number of individuals with a registration status of Active and a confirmed employment with the Institution.	Federal
