ARIZONA MORTGAGE BROKER BRANCH LICENSE

Who is required to have this license?

Each office location of a licensed Mortgage Broker, located in or outside of Arizona, which conducts mortgage broker business involving Arizona real estate.

A.R.S. Section 6-901 - A “person” who for compensation or in the expectation of compensation either directly or indirectly makes, negotiates or offers to make or negotiate a mortgage banking loan or a mortgage loan.

A.A.C. R20-4-102 - “Person” means a natural person or any legal or commercial entity including a corporation, business trust, estate, trust, partnership, limited partnership, joint venture, association, limited liability company, limited liability partnership, or limited liability limited partnership.

Who does not need this license?

See the Mortgage Broker licensing exemptions under A.R.S. Title 6, Chapter 9, Article 1.

Pre-requisites for branch license applications?

You must currently hold or have submitted a Mortgage Broker license with AzDFI.
