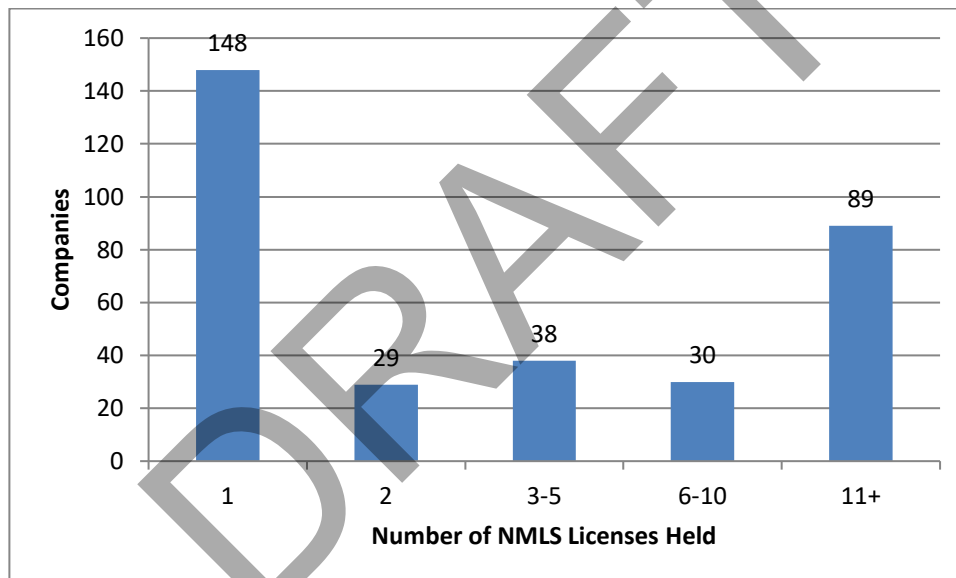

## Money Transmitters and Authorized Agents

NMLS has recently deployed functionality to allow Money Transmitters to upload lists of their authorized agents to state regulators. As of March 31, 2017, 31 states have instructed their Money Transmitters to utilize the Uniform Authorized Agent Reporting (UAAR) functionality.

### Money Transmitters in NMLS:

- Companies: 348
- Total state licenses held: 3,193
- 56% of the companies are licensed in more than one state
- 89 companies are licensed in more than 10 states
- 190 companies are currently reporting 274,939 Active Authorized Agent relationships in NMLS, and 113 companies are reporting no agents used
- NMLS contains 177,244 Active Agent Locations, with 53,051 used by multiple principals
- Ten companies have uploaded over 5,000 agents
