Upload File Format Specifications

- The file must be in one of the formats specified below.
- Failure to provide the file in ".csv" format will prevent the upload of the file to NMLS.
- Failure to provide the column headers exactly as identified below will prevent the upload of the file to NMLS.
- Failure of a single row will result in the failure of the entire file. Errors must be resolved and the entire file uploaded again.

Validation Errors

After the Company uploads the file, the system immediately performs validations. If any error is encountered, records in the file will not be processed and will need to be corrected. Errors that could be encountered include:

Additional Considerations

- CSV upload will not be used to create an initial MSBCR filing.
- Comments and PDF files cannot be input via CSV files.
- No validations are performed on the 'Description' column.
- There will be no mechanism to display the upload history or errors on the upload file..
- All valid rows will be processed. Numeric values will overwrite existing value.
- Values not provided in the CSV will be retained on the pending filing.
