

AMENDING REGISTERED LOCATIONS

Registered locations are initially identified by a company user when a Company Relationship is created (for more information on creating a Company Relationship, refer to the <u>Creating</u> <u>Relationships & Sponsorships Quick Guide</u>). Company users have the ability to amend an individual's registered location(s) at any time thereafter.

NOTE: If only one registered location exists when making an amendment, it is important to add the new location prior to removing the previous location.

Adding a Registered Location

- 1. Navigate to the <u>NMLS Resource Center</u>.
- 2. Click the Log in to NMLS button in the upper right corner.
- 3. Click the **Filing** tab.
- 4. Click the **Relationships** link on the submenu.
- 5. Enter search criteria for the individual and click the **Search** button.
- 6. Click the NMLS ID hyperlink for the appropriate individual.
- 7. Click the Edit icon (see Figure 1).

- 6. Click the **NMLS ID** hyperlink for the appropriate individual.
- 7. Click the **Edit** icon (see *Figure 4*).
