

ENDING RELATIONSHIPS AND SPONSORSHIPS

NMLS records will continue to show company relationships and company license sponsorships to State Regulators until a relationship is ended. Failure to keep records up to date may affect your compliance requirements with State Regulatory Agencies.

Both companies and individuals have the ability to end an active relationship in NMLS. Each party is equally responsible for keeping the record up to date and accurate in NMLS. NMLS will automatically notify State Regulators regarding the sponsorship removal.

Step 8: Enter the *End Date* (required), *Reason for Ending* (required), *Explanation for Ending* (optional).

Step 9: Click End Relationship button.

Step 10: A confirmation screen will appear; click End Relationship if you wish to proceed.

NOTE: Ending a Relationship automatically removes all sponsorships associated with the individual.

Once the relationship is ended, access to the individual's record will also be removed. An email notification will be sent to the company and the individual notifying them that the relationship has been ended and company access has been removed.

Remove a Sponsorship

A company has the ability to remove the sponsorship of an individual license in NMLS without ending the relationship with the individual. To remove sponsorship, follow the steps below.

Follow Steps 1 – 6 above to locate the individual's information.
