

ENTITY NOTIFICATIONS

This document will give a brief summary of each type of notification you may receive as a Surety Company, Surety Bond Producer, and Principal.

Subject	Recipient	Description
Company Surety Bond Signed	Licensee (Principal)	A bond written for the licensee is ready to be reviewed and signed.
Surety Entity Company Access Granted	Surety Bond ProducerSurety Company	Authority has been granted to issue bonds.
Surety Bond Cancelled	Licensee (Principal)	A Surety Company has set a cancellation date on a bond.
Surety Bond Rescinded	Licensee (Principal)	A bond cancellation has been rescinded.
Surety Bond Reinstated	Licensee (Principal)	A cancelled bond has been reinstated.
Broker of Record Change Pending	Licensee (Principal)	Sent on the Effective Date of a Broker of Record Change to notify the licensee that it is pending.

Subject	Recipient	Description
Authority to Issue Bonds Withdrawn	Surety Bond ProducerSurety Company	The licensee (principle) has removed the authority to issue bonds from the surety company or surety bond producer.
Authority to Issue Bonds Withdrawn	Licensee (Principle)	The surety company or surety bond producer has removed its authority to issue and manage bonds on behalf of the licensee (principle).
Company Broker of Record State Authorizations Required	Surety Bond ProducerSurety Company	A broker of record change has been processed and now, one or more bonds associated to the change are in states where your entity does not currently have authority to issue bonds.
Company Broker of Record Change Rejection	Surety Bond ProducerSurety Company	A broker of record change has been declined.
Surety Bond Declined	Surety Bond ProducerSurety Company	A licensee has declined a bond.
Surety Bond Request for Correction	Surety Bond ProducerSurety Company	A licensee has requested a correction on a bond.
Signatory Designation	Individual (Control Person)	The individual receiving this email has been designated as the signatory on a bond.
Surety Bond Signed by Designated Individual	Surety Company	The details of the surety bond signed for the company by the designated MU2 individual.
Signatory Removal	Individual (Control Person)	The individual receiving this email has been removed as the signatory on a bond.
Surety Bond Returned to Surety	Surety Bond ProducerSurety Company	Undelivered bond(s) have been returned to the surety for upgrade and signature due to a new bond form version introduced by the state regulator.

Surety Bond Returned to Surety (Bond Version Change)	Licensee (Principle)	Undelivered bond(s) have been returned to the surety for upgrade and signature due to a new bond form version introduced by the state regulator.
Company Returns Bond/Rider to Surety (Bond Version Change)	Individual (Control Person)	The individual receiving this email will be alerted that the bond was returned and will require resignature prior to delivery to the regulator.
