Any change, even a punctuation or capitalization change, to the first, middle, last, or suffix fields of the user profile name is considered a name change. Upon confirmation of the name change, the user will be removed as a representative from all active associations. Notification, including the representative's old and new name, will be sent to subscribed Surety Bond Producer users and all Surety Companies with affected associations. Notification to the Surety Company will include a list of affected associations for that Surety Company with a link to the <i>Manage Association Detail</i> page for each association. Notification to Surety Bond Producers will include a list of all affected associations across surety/underwriting companies. In addition, the existing Surety Association Representative Removed notification will be suppressed so	State
37997	Surety Bonds: Representative name change – no active associations	that NMLS does not trigger redundant notifications to the same parties. When the name on a Surety Bond Producer user profile is changed for a user who is a representative but not named on an active association the user making the change will be warned that a new account should be created if the name change is being made to replace the individual with a new individual. Any change, even a punctuation or capitalization change, to the first, middle, last, or suffix fields of the user profile name is considered a name change. Notification, including the representative's old and new name, will be sent to subscribed Surety Bond Producer users.
