

NMLS Release 2015.1 Release Portfolio

Scheduled for Release: January 26, 2015

The purpose of this portfolio is to communicate system enhancements targeted for Release 2015.1. Targeted system enhancements and updates listed in this portfolio are committed to Release 2015.1. However, as development proceeds, it is possible that changes will be made to the approach to some enhancements or that some of the enhancements may be removed from the release.

Roadmap enhancements targeted for Release 2015.1 include:

• Mortgage Call Report (MCR) – The MCR will be updated to allow licensees to report servicing activity as well as more accurate application information.

Mortgage Call Report

SUMMARY: The MCR will be updated to allow licensees to report servicing activity as well as more accurate application information.

NOTE: MCR Updates will be developed in 2015.1 but will not be deployed until April 1, 2015, the first day to begin reporting Q1 2015 MCR information. Any new initial MCR filing (quarterly, FYE, any available year) created on or after April 1, 2015 will be in this new form version until a future form version is released.

Financial Condition (FC)

Schedule A-060: Mortgage Loans Held for Sale and Held for Investment, UPB will be modified to include values for Qualified and Non-Qualified Mortgages. Completeness Checks will also be added to ensure data entry integrity. The new fields will only be required for licensees completing the Expanded MCR filing.

Residential Mortgage Loan Activity (RMLA)

Section I – The following information will be collected for both Standard and Expanded MCR filings:

- The Application Data will be updated to include Net Changes in Application Amount as well as totals for the Application Pipeline and Application Pipeline Results. Completeness Checks will also be added to ensure data entry integrity.
- The Closed Loan Data will be updated to include values for Qualified and Non-Qualified Mortgages.
- A new grouping will be added to the end of Section I and will contain rows to account for Loans Serviced.

Section III – The following information will be collected for only Expanded MCR filings:

- Loans Paid Through Short Sale
- Servicing Activity
- Rate Type on Loans Serviced
- Loan Type on Loans Serviced
- Serviced Loans LTV Distribution

Completeness Checks will also be added to ensure data entry integrity.

A new navigation panel section will be added for Loans Serviced – Nationwide Totals. The following information will be collected for both Standard and Expanded MCR filings:

- Servicing Activity
- Servicing Transfers During the Quarter

NOTIFICATIONS

New and Updated Notifications (State Context)

<u>Test Enrollment Notifications – Company and Individual</u>

Notification text will be updated to reference the NMLS Industry Dashboard.

*Subscribable notifications will be sent to Company Account Administrators unless other users are designated as notification contacts for the new notifications. Regulators must actively assign notifications to users who should receive them. The Manage Notifications section of the left navigation panel under the Admin tab in NMLS should be used to assign notifications.

REPORTS

Disbursement Reports Added to SFTP Server (State Context)

The Control Total, the Daily Ledger by Disbursement Date, and Daily Ledger by Transaction Date reports will be added to the SFTP server.

Payment Processing Report Enhancements (State Context)

The following updates will be made to the payment processing reports:

- Add a Repayment Indicator to the Daily Ledger by Disbursement Date and Daily Ledger by Transaction Date reports to identify transactions that are repayments for a previous failed payment.
- Add the license status to the Failed Payment Aging Report.
- Add the timestamp for transactions on all payment processing reports.
- Conform the payment processing reports to other reports by adding report name and time stamp to every report.
