<b>22398</b>	ACN Detail - Present the Redlined Filing for ACN Processed/Cancelled Filing Link	The View ACN Processed Filing and View ACN Cancelled Filing links will be updated to show a redline view of the ACN Processed/Cancelled Filing and the filing created prior to the creation of the ACN.	State
<b>22091, 22400</b>	MCR - Update formatting on Certain RMLA Pages	The column width of the Average Size (\$) column will be expanded so that the title fits on one line and the column header itself is not two rows high. This only applies to the print version of the filings. The formatting changes will be made to Section I – MLO(s), Section III – Loans Serviced Under MSRs, Section III - Loans Serviced for Others, and Section III - Loans Serviced by Others on the MCR Filing. The Section I changes apply to both the Standard MCR and Expanded MCR filings and the Section III changes apply to only the Expanded MCR filing.	State
<b>22250</b>	Account Admin - NMLS ID Will Now Have a Hyperlink on the User Account Profile Page	On the User Account Profile Page in the Admin tab, the NMLS ID will be updated to be a hyperlink to the entity's record in the Composite View tab.	State and Federal
<b>22106</b>	Paging Will Reflect Record Count When all Records are Displayed on one Page	When paging exists (e.g. on the Historical Filings pages) the System will display a footer on the bottom of the page indicating that <a> to <b> of <z> records are displayed.	State and Federal
<b>19360</b>	General - Update Terms of Use to address FISMA POA&M Outstanding Items	A notification message regarding system use has been added directly under the titles for the State Agency, Federal Agency, Industry, and Consumer Access Terms of Use to satisfy Federal Information Security Management Act (FISMA) requirements.	State, Federal, and Consumer Access
<b>22076</b>	Move Home Tab in Federal Registry to Far Left	The Home tab in the Federal Registry will be moved to the far left of the existing tabs to align with the placement of the Home tab in the State Licensing context.	Federal

SCR Number	Category	Description	Context
22376	NPPI Masking	The State of Government Issued Identification Number and Passport Issuing Country values are masked in historical filings when viewed by a regulator user who does not have the View Confidential Information role. The System will be updated to not mask these fields for all Regulator users.	State
22383	Work List	Regulator account administrators are being navigated to the My Work List page when clicking the Work List button on the Tasks tab home page. The hyperlink will be updated to navigate Regulator account administrators to the Agency Work List & Assignment page. Regulator users that are Organization Users (OUs) will continue to be navigated to the My Work List page.	State
22366	Entitlement	The CAPTCHA screen, which is displayed after two failed login attempts, is requiring the user to click the Next button to complete the action. The System will be updated to also complete the action when the user presses the Enter key.	State and Federal
22458	NPPI Masking	When a federal-only institution user (an institution user with federal filing authority but no state filing authority) is in the state context and attempts to view NPPI information in the Personal Information section, they are seeing the 'Access Denied!' message even though they have the View Confidential Information role and have relevance to the individual. The same issue exists for state-only companies (a company user with state filing authority but no federal filing authority) viewing individual information in the federal context. The system will be updated to allow federal-only institution users and state-only company users to unmask NPPI information under the Personal Information section both in their native and non-native context.	State and Federal
22385	NPPI Masking	When Requesting Filing Authority (to become dually-regulated), a federally registered institution is seeing an Access Denied message when attempting to view their IRS number on the request page. The system will be updated to allow the IRS number to be displayed when the View link is clicked.	Federal
