Changes to the mailing address or legal name must be processed and approved through CA-DRE before you submit the amendment request through NMLS. These requests require a separate application and/or additional documentation to be submitted to CA-DRE.

Filing an amendment through the NMLS does not authorize you to conduct business with the changes requested unless the changes are reflected on your CA-DRE license records.
