GENERAL INFORMATION

Transition in NMLS

This license is a combination of lender license, mortgage broker license, loan solicitation license, and loan servicer license. Companies holding two or more of the following Vermont licenses are able to submit a license transition request through NMLS by filing a Company Form (MU1) and an Individual Form (MU2) for each of their control persons: Lender License, Mortgage Broker License, Loan Solicitation License, and Loan Servicer License. **The transition to this license is optional.** Submit license transition requests through NMLS by filing a Company Form (MU1) and an Individual Form (MU2) for each of your control persons and Branch Form (MU3) **between March 1, 2020 and May 15, 2020. Transition requests will not be accepted after May 15, 2020.**

Branch offices holding two or more of the following licenses in Vermont can also transition to the new combination license type by completing and submitting a Branch Form (MU3) through NMLS: Lender License, Mortgage Broker License, Loan Solicitation License, and Loan Servicer License. Transition is not necessary for any branch that holds a single license type.

Note: If you already have a record in NMLS and have submitted these forms in the past, you do not need to re-enter your company information into NMLS. You will only need to identify the business activities your company conducts and the states in which the various activities are conducted. Then, you will select the appropriate license in VT, and complete a few state-specific fields.

It is important that current licensees have the appropriate transition number available when completing and submitting their Company Form (MU1), so they are not charged a new application fee. Please contact the Vermont Department of Financial Regulation directly for information regarding the transition number to be used. Note: *Fees collected through NMLS are NOT REFUNDABLE OR TRANSFERABLE.*

The Vermont Department of Financial Regulation encourages current licensees to update their NMLS forms at least two weeks before they request transition to the new license type, so there will be no delays at the time of transition.

Vermont Department of Financial Regulation does not issue an electronic license or a paper license for this license type. Approval in NMLS serves as the official record.

- Do not upload the same company documents multiple times. Unless the document is state-specific, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents, be sure to indicate the applicable state.
