GENERAL INFORMATION

Who Is Required to Have This License?

This registration is required of any nonprofit organization qualifying for tax-exempt status under section 422.3 of the Internal Revenue Code that offers housing services to loan and moderate income families that would otherwise be required to obtain a mortgage banker or mortgage broker license, but that is specifically exempt pursuant to section 5335B.2, subsection 8.

Who Does Not Need This Registration?

- Mortgage Banker or Mortgage Broker licensees

Pre-Requisites for License Applications

- None.

Iowa Division of Banking issues a paper license for this license type.

Document Uploads Guidance

Documents that must be uploaded to the *Document Uploads* section of the Company Form (MU1) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).
- Only upload documents relevant to the company application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Surety Bonds), be sure to indicate the applicable state.
