



Surrender Jurisdiction-Specific Requirements



MARYLAND MORTGAGE LENDER LICENSE

Instructions

1. Licensee must notify the Office of the Commissioner of Financial Regulation when terminating business under this license. Notification must be made by submitting a *Surrender Request* filing for the Maryland Mortgage Lender License through NMLS.
2. The acceptance of the surrender is at the Agency's discretion.
3. There is no fee to surrender.
4. No additional information or documentation is required to be sent to the Office of the Commissioner of Financial Regulation at this time. However, we may request additional information upon review of the filing; watch your e-mail for such requests until the surrender request is accepted.
