GENERAL INFORMATION

Who Is Required to Have This License?

This license is required for the executive office of any person (defined in Md. Code Ann., Com. Law §14-1901) acting as a credit services business (defined in Md. Code Ann., Com. Law §14-1901). Refer to Md. Code Ann., Com. Law §14-1903, and Fin. Inst. §§11-302 and 11-201 *et seq.* for legal requirements.

Note: Based on the decision by the Court of Appeals of Maryland in *Cashcall, Inc. v. Maryland Commissioner of Financial Regulation (139 A.3d 990 (2016))*, this license requirement extends to a person that engages in assisting Maryland consumers to obtain small loans bearing annual interest rates that would be usurious under Maryland law, who immediately purchases the loans after their issuance and thereafter collects all payments due on the loans from the consumer. This licensing requirement exempts any person licensed to make loans under Maryland law (consumer loan license, installment loan license, or mortgage lender license) or United States law who is actively engaged in the business of making loans or other extensions of credit to Maryland residents.

Activities Authorized Under This License

This license authorizes the following activities...

- Consumer loan brokering
- Credit Repair
- Non-mortgage loan modifications

Pre-Requisites for License Applications

- Electronic Surety Bond (ESB) in the amount of \$12,000 must be provided through NMLS. See the [Electronic Surety Bond item](#) below.

Maryland Commissioner of Financial Regulation provides a .pdf file to allow the licensee to print a paper license for this license type.

Document Uploads Guidance

Documents that must be uploaded to the *Document Uploads* section of the Company Form (MU1) in NMLS are

indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).
- Only upload documents relevant to the company application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.

- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Surety Bonds), be sure to indicate the applicable state.
