## GENERAL INFORMATION

### Who is required to have this license?

This license is required for anyone making a loan of \$6,000 or less under the Maryland Consumer Loan Law. See Maryland Code Annotated, Financial Institutions Article §11-301 *et seq* for information.

### Activities Authorized Under This License

This license authorizes the following activities...

- Consumer loan servicing
- Consumer loan lending
- Industrial loan lending companies
- Refund anticipation lending

### Pre-Requisites for License Applications

- This license should only be applied for by a company that also holds or is applying for MD Installment Loan License.
- The Electronic Surety Bond amount must be increased by \$12,000 through NMLS for each additional location.

Maryland Commissioner of Financial Regulation provides a .pdf file to allow the licensee to print a paper license for this license type.

## Document Uploads

Documents that must be uploaded to the *Document Uploads* section of the Branch Form (MU3) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).
- Only upload documents relevant to the company application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Certificate of Authority/Good Standing Certificate ), be sure to indicate the applicable state.
