### **Instructions**

- 1. File the surrender/cancellation request through NMLS.
- 2. There is no fee to surrender/cancel.
- Send nothing to the North Carolina Office of the Commissioner of Banks for surrender/cancellation.
   We may request additional information upon review of your surrender/cancellation; watch the NMLS license deficiency or requirements section for such requests.
- 4. The branch manager should not remove company access until the branch license surrender/cancellation request has been submitted through the Nationwide Multistate Licensing System & Registry (NMLS).
- 5. Remove mortgage loan originator sponsorships associated with the surrendering branch unless the MLOs are under another North Carolina licensed location for your company.
