

NEBRASKA INSTALLMENT LOAN COMPANY LICENSE

Instructions

When making changes to your record in NMLS, Nebraska requires advance notification for some changes; see checklist below for details.

Fees

- 1. Nebraska does not charge amendment fees for the following changes through NMLS:
 - Change of Name
 - Change of Other Trade Names
 - Change of Control Persons
 - Change of Ownership
- 2. Nebraska collects amendment fees for the following changes through NMLS during filing:
 - Change of Address (\$150 fee plus the NMLS processing fee). Fees collected through the NMLS ARE NOT REFUNDABLE.

How to submit Agency specific documents

- If you are required to upload documents for an amendment that doesn't require Advance Change Notice:
 - a. In the NMLS document upload section, select the applicable document type.
- 2. If you are required to provide document(s) outside of NMLS:
 - a. If documents are indicated that should be sent via **mail**, send along with the checklist within 5 business days to the following address:
