GENERAL INFORMATION

Who is required to have this license?

The license requirements for premium finance agencies are found primarily in Article 12-B of the New York Banking Law (BL) and regulations thereunder. BL Section 555 provides, in part:

No person except a lending institution or an authorized insurer shall engage in the business of a premium finance agency without a license therefor obtained from the superintendent, as provided in this article.

This license should only be applied for by a company that also holds or is applying for the NY Premium Finance Agency License.

In addition to the items listed in the [checklist below](#), the New York State Department of Financial Services (NY-DFS) may require, as it deems necessary, the submission of any other information or documentation.

Activities Authorized Under This License

This license authorizes the following activities:

- Premium finance company activities

Pre-Requisites for License Applications

- This license should only be applied for by a company that also holds or is applying for a NY Premium Finance Agency License. [See the NY Premium Finance Agency License New Application Checklist for more information.](#)

NY-DFS does issue paper licenses for this license type.

Document Uploads

Documents that must be uploaded to the *Document Uploads* section of the Branch Form (MU3) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).

- Only upload documents relevant to the branch application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same branch documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents, be sure to indicate the applicable state.
