If you are required to upload documents for an amendment that doesn’t require ACN, select the applicable document type in the NMLS *Document Uploads* section.

This document should be named <i>OH-Trade Name-Assumed Name</i> . Note: When adding an Other Trade Name to a Branch Form (MU3), it must also be added to the Company Form (MU1). Note: There is no fee for an addition or modification of other trade name.	NMLS <i>and</i> Upload in NMLS: under the Document Type <u>Trade Name/Assumed Name Registration Certificates</u> in the <u>Document Uploads</u> section of the Company Form (MU1).
