<input type="checkbox"/>	<p>Addition or Modification of Qualifying Individual/Operations Manager: Submit an ACN for an addition or change in Qualifying Individuals within the Company Form (MU1) in NMLS. 15 Days' notice must be provided for this change.</p> <p>Each mortgage company must maintain an "operations manager" (OM) who must be a licensed mortgage loan originator in Ohio, and must be listed as a qualifying individual on Form MU1. Provide a resume with detailed job descriptions and duties performed to show experience that meets the requirements contained in ORC 1322.12. In particular, the experience must include "at least three years of experience as a mortgage loan originator or registered mortgage loan originator."</p> <p>Upload in NMLS any additional proof of industry experience (such as IRS Employment Records that match the candidate's employment history) under <u>Verification of Experience</u> in the <i>Document Uploads</i> section of the Individual Form (MU2/MU4).</p>	<p>NMLS <i>and</i> Upload in NMLS under <u>Verification of Experience</u> in the <i>Document Uploads</i> section of the Individual Form (MU1).</p>
