




COMPANY NEW APPLICATION CHECKLIST

Agency-Specific Requirements



OREGON CONSUMER FINANCE LICENSE

This document includes instructions for a company (corporation location) new application request. If you need to complete a new application for a branch location (authorized delegates are not considered a branch in NMLS) or individual; refer to the appropriate new application checklists.

NOTE: A person brokering or facilitating consumer finance loans is required to be licensed as a consumer finance lender in Oregon. A broker, facilitator, or agent applying for a consumer finance license does not need to provide loan documents or underwriting criteria.

Fees

- **New License costs: \$600.00.** A \$15 fee for a credit report will be added if one has not been authorized through NMLS in the past 30 days for the branch manager.
- **Annual License Renewal costs: \$700.00** (which includes a \$100 NMLS processing fee)
- Fees collected through the NMLS **ARE NOT REFUNDABLE**.






The qualifying person's experience determining the consumer's qualifications by reviewing credit reports, verification of income, employment history, debt to income ratios and the consumer's ability to pay.3. The qualifying person's responsibilities in the day-to-day operations of the lending company. <p>NOTE: Brokers, facilitators, and agents are not required to provide a qualifying individual.</p>

Individuals will be required to complete an Identity Verification Process (IDV) along with an individual attestation before a license request for your company can be filed through NMLS.</p> <p>NOTE: Credit reports are <u>REQUIRED</u> and must be authorized before an application is accepted.</p>

See the ESB Adoption Table and the ESB for NMLS Licensees page of the NMLS Recourse Center for more information. Note: Surety bonds submitted via the <i>Document Uploads</i> section will not satisfy this requirement.

Oregon will review the filing and all required documents and communicate with you through NMLS.
