REQUEST FOR EXPEDITED REVIEW OF MORTGAGE LOAN ORIGINATOR APPLICATION FOR MILITARY SERVICE MEMBERS, MILITARY VETERANS, AND MILITARY SPOUSES^{*}

*Definitions:

- "Military service member" means a person who is on active duty.
- "Active duty" means current full-time military service in the armed forces of the United States oractive duty military service as a member of the Texas military forces, or similar military service of another state.
- "Armed forces of the United States" means the army, navy, air force, space force, coast guard, or marine corps of the United States or a reserve unit of one of those branches of the armed forces.
- "Texas military forces" means the Texas National Guard, the Texas State Guard, and any othermilitary force organized under state law.
- "Military veteran" means a person who has served on active duty and who was discharged orreleased from active duty.
- "Military spouse" means a person who is married to a military service member.

**Additional information regarding eligibility: Military Service Members, Military Veterans, and Military Spouses that apply for temporary authority in NMLS are eligible for this expedited review.
