

## Company Attest and Submit

### Overview/Policy

The "Attest and Submit" button will only appear if the Company Form (MU1) passes all completeness checks, including Individual Form (MU2) attestations.

The Attestation must include the name of a natural person after the "I". The applicant or licensee's name should appear after the "of".

When clicking the "Attest and Submit" button, applicants and licensees are making a legal attestation to all states in which they are applying for or maintaining a license through NMLS.

After clicking the "Attest and Submit" button, the applicant or licensee is taken to a one-time payment page to make an electronic payment for the filing when fees are applicable. Once payment information has been successfully submitted the filing becomes viewable by the regulator(s). NMLS only accepts payment by credit card (Visa or Mastercard only) or ACH transfer.

#### Correct Completeness Check Errors

1. Click on the **section link** with the error.
2. Correct the **Completeness Check** error.
3. Proceed to the Attest and Submit section again to attempt to submit the filing.
4. Repeat **steps 1 through 3** until all errors have been resolved.
