

Company License/Registration Information

Overview/Policy

The License/Registration Information displays a list of all license/registration requests pending submission as well as any previously submitted license/registration requests. Users can request a new license, review existing requests, cancel a previously submitted request, or request to withdraw an existing license/registration.

A company has the option to request the withdrawal of an application prior to an approval by a regulator. A company can surrender/cancel a license/registration that is currently approved.

How To

Surrender/Withdraw:

1. If the user wants to surrender an approved license/registration, click **Surrender** for the corresponding state license.
2. If the user wants to withdraw a pending license/registration, click **Withdraw** for the corresponding state license.
3. Click **Request License** to go back and apply or transition an additional license/registration.
4. Click **Continue with Filing** to navigate to the next section of this filing.
