



Identifying Information

Overview/Policy

An individual's Full Name is the legal name found on his or her birth certificate, social security card, marriage license, US or foreign passport, state-issued ID or state-issued driver's license. Individuals should not use nicknames or professional/academic suffixes as part of their legal name. An individual should ensure that their state issued ID matches their legal name.

Home, cell and fax numbers and Government issued-ID and passport information are optional.

An individual whose legal Full Name has changed since the original record was created in NMLS should check the state specific amendment checklist on the NMLS Resource Center to determine if you must submit documents outside the system supporting a legal name change.

Helpful Hints

- 1. Has your legal name changed?
 - This field provides individuals the ability to change their legal Full Name in NMLS and file this name change with their regulator(s). This need only be done when the legal Full Name has changed from what is currently reported in the system.
- 2. Do not enter "Mr.", "Mrs.", "Ms.", or "N/A" in the suffix field.
- 3. If "Mr.", "Mrs.", "Ms.", or "N/A" currently appears as a suffix in your Full Name, utilize the *Has your legal name changed*? section to re-enter your Full Legal name leaving the suffix field blank.
- 4. Your legal Full Name must match your government issued ID if you plan to register for a test or provide prints for a Criminal Background Check.
